In preparation for running for council, I started my own media business which allows me to work for clients inside and outside the community. And some of your faces are familiar from seeing you during our work together with various volunteer initiatives during the past two years.

As a member of the Minden Hills Events Planning Committee, I used my event planning knowledge to plan a successful and financially beneficial event on Canada's 150th Birthday for the municipality and continue to volunteer with a group of amazing people responsible for events in the township.

Other work includes being a member of the County Tourism Task Force – where the goal to improve the food tourism in our County through #myhaliburtonhighlands, working with a team of like-minded people looking to make things just a bit better for our tourism industry, one step at a time.

Fay Martin of the Housing Task Force in Minden recently invited me to speak on CANOE FM about tiny homes and senior campuses and their potential in Minden. It was important to me to do some research before coming here today, as a journalist who is constantly asking questions. I know how important lake health is to all of you, as it is to promote the cultural, social and environmental interests of the residents on and in the vicinity.

Research told me your association studies and reports on all governmental plans affecting its members and makes such representations as are deemed desirable to the various levels of government. Your lake steward, Ken Brownhill, had great things to say in your Spring Newsletter about the Love your Lake program.

He said natural shorelines are extremely important to maintain water quality, ecosystems, and overall lake health. And I 100 percent agree that it's important to understand just how vulnerable our lakes really are.

Part of that health is determined and measured by the amount of pollution seeping from septic tanks.

Residents are suggested to have their septic tanks pumped every two to three years to promote optimal shore line health.

Minden Hills have been active in responding to lake associations' requests for a mandatory inspection program. Which many of you would suggest is a long-time coming, so I support this initiative to better ensure your lake stays healthy for years to come.

My best service to you will be doing my job. Like the back of my business card says, what can I do for you today? And even if all I can do is listen, it is ultimately important to me to talk to as many people as I can to do my own informal surveys. Because we all think about what can be done and it's a matter or working together towards change to make things work - realistically.
